We would like to inform you that the Board of Directors at their Meeting held on 19<sup>th</sup> day of August, 2016 has approved the Expansion plan of Company's SEZ Unit situated at Indore Special Economic Zone, Plot No. 15 to 18, Phase-1, Sector-III, Pithampur (MP); by setting up of complete manufacturing facilities by installation of Tape Line and Looms with clean room facilities for manufacturing of food grade jumbo bags. The company is already having finishing section at SEZ and now going to set up the complete facility for manufacturing of fabric, lamination and food grade jumbo bags and FIBC Bags.


The cost of project is estimated to be Rs. 2810 Lakhs. The Bank of India has appraised the project and sanctioned the credit limits (Term Loan) of Rs. 1900 Lacs for this project vide Sanction Letter dated 05<sup>th</sup> August, 2016. 
