Toll tops 1,400, 5k still missing

NEPAL CALAMITY: Over 13,000 people rescued; search operations continue in eight flood-hit districts

Kathmandu: The death toll from the devastating flash floods in Nepal neared 1,400 on Saturday as more bodies were recovered from eight affected districts, officials said.

Rescue teams continued searching for around 5,000 people, including at least 589 foreign nationals, while more than 13,000 people have been rescued. The disaster also killed at least 21 people on the Chinese side, while more than 500 remain missing in Tibet, as per Chinese media reports.

Of the bodies recovered in Nepal, 758 were adults and 85 were children, while 501 were found with body parts missing. Chitwan recorded

the highest toll at 360, followed by Nawalparasi West with 230 and Nawalparasi East with 222. Authorities

said 1,030 bodies were temporarily buried after procedures, including DNA collection, were completed. Only 96 bodies have been handed over to families after identification.

Identification remains a major challenge as many bodies were badly damaged or decomposed after being swept downstream. DNA testing has become crucial, but the process is time-consuming.

Major rescue operations are on at hydropower projects, where hundreds of people are believed to be trapped in tunnels. Experts from India and China are assisting Nepali teams. An Indian tunnel rescue team working with the Nepalese Army has made a temporary track inside the Chilime tunnel in Rasuwa to allow heavy equipment to reach affected areas.

Joint teams continued search and rehabilitation operations for the 11th day.
